Cookie Policy – Information on the processing of personal data pursuant to Art. 13 of the EU Regulation 2016/679

Cookie

Preamble

This general information on the use of cookies by Soilmec S.p.A. refers to the DMS Manager 4.0 platform: dmsmanager.soilmec.com.

Definitions, characteristics and application of the regulation

Cookies are small text files that websites visited by users send to and store on their computer or mobile device, in order to be re-transmitted to the same websites at the next visit. Thanks to cookies, a website remembers the user's actions and preferences (such as login data, chosen language, font size and other display settings, etc.) so that they do not need to be specified again when the user returns to visit said website or browse its pages. Cookies are therefore used to perform computer authentication, to monitor sessions and to store information concerning the activities of users who access a website. They may also contain a unique identifier that tracks the user's navigation within the same site for statistical and advertising purposes. When navigating a website, users may happen to receive some cookies on their own computer from websites or servers different from the one they are visiting (the so-called "third party" cookies), but not in the case of the DMS Manager 4.0 platform which does not use tracking cookies, nor third-party cookies. Some activities could not be carried out without the use of cookies, which in certain cases are hence technically necessary for the site to function.

There are various types of cookies, based on their characteristics and functions. These can be stored on the user's computer for different time periods such as session cookies, which are automatically deleted when the browser is closed, and persistent cookies, which remain on the user's device until a set expiration date.

According to the applicable Italian law, the express consent of the user is not always required for the use of cookies. Specifically, consent is not required for "technical cookies", namely those used for the sole purpose of transmitting a communication on an electronic communication network, or insofar as this is strictly necessary to provide a service expressly requested by the user. In other words, these cookies are essential for the functioning of the website or necessary to carry out the activity required by the user.

Among the technical cookies, which do not require an express consent for their use, the Italian Data Protection Authority (see the Provision *Simplified arrangements to provide information and obtain consent regarding cookies* dated 8 May 2014 and subsequent clarifications, hereinafter referred to as "Provision"), also includes:

- "analytic cookies", used directly by the website manager to collect aggregate information on the number of visitors and the pattern of visits to the DMS Manager 4.0 platform;
- navigation or session cookies (for authentication);
- functional cookies, which allow users to navigate as a function of certain pre-determined criteria (such as language or products to be purchased) so as to improve the quality of the service provided.

On the other hand, a prior consent of the user in the case of "profiling cookies" is required. Said cookies are aimed at creating user profiles and are used to send ads messages in line with the preferences shown during navigation.

Types of cookies used by the DMS Manager 4.0 platform and (de-)selection

The DMS Manager 4.0 platform uses the following cookies that they cannot be deselected because they are essential for the use of the services, they do not require consent and are integrated into the platform:

- Technical cookies browsing or session cookies which are strictly necessary for the functioning
 of the Platform or for providing the contents and services requested by the user.
- Functional cookies, which are used to enable specific functions of the Platform and a series of pre-determined criteria (such as language) in order to improve the quality of the service provided.

ATTENTION: by disabling technical and/or functional cookies, the Platform may not be accessible or some services or specific functions of the Platform may not be available or work properly, thus requiring the user to manually change or enter certain information or preferences at every Platform.

More in detail, the technical and analytical cookies sent by Soilmec S.p.A. through the Platform are the following:

The DMS Manager 4.0 platform does not use tracking cookies or third-party cookies.

The user may block or delete (in whole or in part) technical and functional cookies through the specific functions of the Browser. Nevertheless, we inform the user that declining technical cookies could result in the impossibility to use the Platform, view its contents and use the relative services. By blocking functional cookies, some services or certain functions of the Platform may not be available or work properly, thus requiring the user to manually change or enter certain information or preferences at every Platform visit.

The choices made concerning Platform's cookies will, in turn, be recorded in a special cookie. However, in some circumstances, this cookie may not function properly: in such cases, it is advisable to delete unwanted cookies and block their use also by means of the Browser functions.

Preferences referring to cookies shall be reset if the user uses different devices or Browsers to access the Platform.
